

Minutes of the Board of Licking Township Trustees, regular meeting, held at the Twp Hall Jacksontown, OH at 7:00pm on March 1, 2004.

Mr. Miller called the meeting to order with the following members present: Dave Miller, Ron Acord, Joe Cooper and Jill Linn.

The Pledge of Allegiance was recited.

Attached is a copy of all expenditures totaling \$21,090.96.

Minutes of the previous meeting were read, approved, and signed by the Trustees.

#### CORRESPONDENCE:

1. Received information from the Licking County Planning Commissioners regarding two educational seminars.

There was no Fire Co. report.

Joe Walker issued 2 permits totaling \$60. Mr. Walker mentioned that the violation on Roley Hills Road was tabled at the Zoning Commission meeting. He also mentioned that Jeff Walker will forward information to him regarding Homeland Security.

Mr. Miller mentioned that Mr. Pierce called regarding the church on Ryan Road. Mr. Walker said that he will look into it.

Jeff Preston, from the Licking County Engineers Office, came to the meeting to discuss the water problem complaint regarding the property owned by Myra Chaney in Harbor Hills. After a discussion, Mr. Miller mentioned that they should run a snake through the tile to see if the water will run through it so that the township will have an idea of what the problem is. Mr. Miller said that the township will work within the township right of way.

Linda Thompson asked about the road frontage on McMillen Lane which is located in Harbor Hills. She was informed that since the road has not been dedicated that a permit could not be issued. She was told that after the road is dedicated she would need to go before the Zoning Board of Appeals and request a variance.

Mr. Cooper mentioned that Heath re-filed to annex the 32.615 acres. Mr. Cooper will meet with the Heath Zoning Inspector to see if they are willing to put in a buffer zone to protect the annexed land.

Mr. Cooper made a motion to institute a temporary living fee of \$50 effective immediately to help with the zoning cost. Mr. Acord seconded the motion. Roll call: Miller, yes; Acord, yes; Cooper, yes.

Mr. Cooper made a motion to purchase a box of larvicide with a cost of around \$586.53. Mr. Miller seconded the motion. Roll call: Miller, yes; Acord, yes; Cooper, yes.

Mr. Acord mentioned that Dell Avenue was approved to be closed at St. Rte 13.

Mr. Acord mentioned that we will be receiving paperwork from the State giving Freeman Drive back to the township. Richard Cash mentioned that we need to make sure that the State puts the culvert back in.

The Clerk informed the Trustees that the Fire Levy expires at the end of this year and that it will need to be put on the ballot in November and all paperwork needs to be turned in by August 19th.

Mr. Cooper mentioned that he has received a good response regarding the township clean up day which is scheduled for April 17 & 18. He also mentioned that the county will pickup the trash bags.

Mr. Cooper mentioned that he will talk with Tim Lollo regarding a pavement management plan for the township.
