

Minutes of the Board of Licking Township Trustees,  
Regular Meeting, held at the Fire Co. Station 3,  
Jacksontown, OH at 7:00pm on October 5, 2009.

Mr. Hart called the meeting to order with the following  
members present: Joseph Hart, David Miller and John  
Holman. Jill Linn was absent.

Others present: Robert Snedden, Joe Walker, Mike Wilson,  
Marshall Eubanks, Bill Ours, Mike Harris, Jack Creiglow,  
Charles Krumm Jr., Charles Prince, Rob Mills and Steve  
Patterson.

The Pledge of Allegiance was recited.

Mike Wilson gave the Fire Co. report. They did 101 runs in  
the month of September which brings the year to date total  
to 794 runs. He mentioned that they were selected for two  
grants. One is from the Ohio Department of Natural  
Resources Division of Forestry called the Volunteer Fire  
Assistants Grant in the amount of \$4500. Mike asked to  
spend \$10,000 on the Wild Land Fire Equipment, \$5500 would  
be paid by the Fire Co. and the \$4500 by the grant. The  
second grant is from the Wild Land Personnel Protective  
Clothing Request. The Fire Co. was awarded ten sets of  
wild land fire gear.

Mr. Hart made a motion to approve the request of  
\$10,000 for grass fire equipment with the understanding  
that we have a \$4500 matching fund award. Mr. Miller  
seconded the motion. Roll call: Hart, yes; Miller,  
yes; Holman, yes.

Mike Wilson mentioned that the new computer is up and  
running. Mike asked to purchase four new mattresses which  
will cost around \$1500.

Mr. Holman made a motion to spend up to \$1500 on new  
mattresses. Mr. Miller seconded the motion. Roll  
call: Hart, yes; Miller, yes; Holman, yes.

Joe Walker was not able to attend the meeting but informed  
Mr. Hart that he had nothing to report.

Steve Patterson mentioned that truck no. 1 needs hydraulic work done. He had contacted five different places for an estimate and only received one from Ace Truck Equipment for \$2100. Mr. Miller said that it will be an asset to the truck to have dual control.

Mr. Miller made a motion to spend up to \$2200 to Ace Truck Equipment for a dual control hydraulic system for truck no. 1. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.

Mr. Miller mentioned that we have no room for salt but we will still be receiving the salt at the same price. Steve will be checking on the cinders. Mr. Miller contacted Tim Lollo regarding the Wetlands at Dawes Arboretum who are building a pond by emptying the old pond into the ditch. Tim Lollo told him to contact the Soil & Water Conservation to see if they have a permit and if it will cause a problem in the future. Mr. Miller said there will be meeting with him, Steve, Tim Lollo and Tim Mason to look over the situation within the next couple of weeks.

Mr. Miller mentioned that he turned in the application for the Ohio Public Works Commission.

Mr. Miller said that he received a complaint regarding a resident not mowing in Misty Meadows. He also mentioned that a fence is being put up in the clear zone at the corner of Logan and Newark Avenue in Avondale. Mr. Miller will look into the situation.

Charles Krumm is trying to vacate the road that runs across his property. Mr. Hart said that they will not vacate a road that the township is taking care of. After a heated discussion in which Charles Krumm was being extremely rude and yelling profanity, Mr. Hart asked him to leave the meeting in which he did. Mr. Hart mentioned to Mr. Miller to contact Tim Lollo and Jim Miller about the situation and as long as nothing has changed they were not going to vacate the road.

Bill Ours asked if he got the tile for the ditch on Wilshire would the township dig and level it off. Mr. Miller said that they will work on it.

Robert Snedden mentioned that someone pulled up a tree and tore up his yard. Mr. Miller said that it could have been the electric company but Mr. Snedden said that it was not the electric company but it could have been the cable company.

Mr. Miller made a motion to adjourn the meeting at 7:50pm. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.
