

Minutes of the Board of Licking Township Trustees,  
Regular Meeting, held at the Fire Co. Station 3,  
Jacksontown, OH at 7:00pm on November 2, 2009.

Mr. Hart called the meeting to order with the following  
members present: Joseph Hart, David Miller, John Holman  
and Jill Linn.

Others present: Robert Snedden, Joe Walker, Bill Ours,  
Lloyd Fyffe, Makenna Riley, Sydney George, Shawna George,  
Ron Acord, Charles Prince, Rob Mills and Steve Patterson.

The Pledge of Allegiance was recited. The Pledge was lead  
by Makenna Riley and Sydney George from Girl Scout Troup  
330.

Sydney George informed the township that they were  
collecting hats and gloves for the needy in the Lakewood  
School District. They will be collecting until Christmas  
at Station 3. Mr. Hart thanked them for coming.

Minutes of the October 19, 2009 meeting were read, approved  
and signed by the Trustees.

The financial reports were given to the Trustees.

Mr. Holman made a motion to approve the expenditures  
totaling \$32,241.98. Mr. Miller seconded the motion. Roll  
call: Hart, yes; Miller, yes; Holman, yes.

#### CORRESPONDENCE:

1. Received an email from Brad Mercer regarding driveway  
and culvert permits.
2. Received the annual report from the sheriffs office.
3. Received a call from Kelly Austin from KLA.

Mike Wilson was called out on a fire run before the meeting  
started. Mr. Hart gave the Fire Co. report. The Fire Co.  
received a \$2000 donation from the Buckeye Lake Eagles.  
There were 78 runs in the month of October bringing the

total year to date to 872 runs.

Mr. Hart made a motion to spend up to \$1500 on shirts and hats. Mr. Holman seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.

Joe Walker had no zoning permits. He had one zoning request but that will need a variance. He mentioned that the trailer behind the post office will hopefully be removed.

Mr. Miller took pictures of the weeds on Misty Meadows. He will talk to the lady who made the complaint tomorrow.

Steve Patterson mentioned that the Shelly Co. had done four roads and then broke down. He mentioned that he will start berming the roads that have been done.

Mr. Miller mentioned that the crack seal was done in LeMar Heights and they will be back to do Misty Meadows.

Mr. Miller mentioned that they went around and checked culverts and that they are working on the culvert report. He is also working on the list of roads for load restrictions.

Mr. Hart mentioned that he received old documents from Rodney Hill regarding information he had been given on the cemeteries. Mr. Miller will keep two of the documents in his gun safe. The Fiscal Officer will put the three deeds in the safety deposit box. Mr. Holman will contact Rodney Hill to let him know what the Township will be doing with the documents.

Mr. Holman attended the Zoning Commission meeting. He mentioned that Brad Mercer and Dale Wise have been working on consolidating the current zoning into a new format. He gave Mr. Hart and Mr. Miller a copy. Mr. Hart mentioned that his concerns were that future changes would need to be changed by the county and that there were sections in the new format that are left blank for future use. He would also like to see the language from the approved amendments in the new format instead of a reference document. Mr. Hart mentioned that Joe Walker should have the opportunity to make sure that the language in the new format is the same language in the current zoning, just in another format. Mr. Walker said that he has not looked at it

extensively. Mr. Hart said that he knows that it is a work in progress. Mr. Holman said that Zoning Commission is planning on having another meeting to review questions, have a public meeting and then they will present it to the Trustees for final approval. Further discussion continued.

Mr. Holman asked the Fiscal Officer about the stipend checks for the Zoning Commission and Zoning Appeals Board. The Fiscal Officer said that she will get those done.

Mr. Miller mentioned that the American Legion in Hebron will be here on November 16 at 6:00pm at the Township Hall to dedicate the Licking County Bicentennial Historical Marker which had been dedicated to the Licking Township Veterans and placed on the Township Hall. The regular meeting will follow at the Township Hall at 7:00pm. An ad will be placed in The Beacon and The Advocate inviting the veterans to the dedication.

Robert Snedden asked for a copy of October 5<sup>th</sup> and October 19<sup>th</sup> minutes. He mentioned that the roof on the fruit and vegetable stand on St. Rt. 40 is an eye sore. Mr. Hart mentioned that the township does not have jurisdiction over that. Mr. Snedden also mentioned that Dogwood Lakes is polluting the ponds and they should have sewer plants. Mr. Hart mentioned that the township does not have jurisdiction and he needs to go to the health department. Mr. Snedden mentioned that there are shrubs in the townships right a way at Somerset Road and Roley Hills Road. Mr. Miller said that he will check and see if it is located in the township.

Mr. Holman made a motion to adjourn the meeting at 8:15pm. Mr. Hart seconded the motion. Roll call: Hart, yes; Miller, yes; Holman, yes.
